ORDER:

In the Government order second read above, orders were issued for declaring the revenue villages specified therein to be a local planning area, namely, Tiruchirappalli local planning area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the Government order third read above, orders have been issued giving consent under sub-section (2) of section 24 of the said Act to the Tiruchirappalli local planning authority for the publication of a notice under section 26 of the said Act for inviting objections and suggestions in the preparation of the Master Plan for Tiruchirappalli local planning area.

3. The Director of Town and Country Planning, in his letter fourth read above, has forwarded the draft Master Plan 2045 for the Tiruchirappalli local planning area as approved by the Tiruchirappalli local planning authority, and requested the Government to accord approval under section 28 of the said Act.

4. The Government, after careful consideration, have decided to accept the draft Master Plan 2045 for Tiruchirappalli local planning area, as approved by the Tiruchirappalli local planning authority submitted through the Director of Town and Country Planning in para 3 above.

5. Accordingly, in exercise of the powers conferred by section 28 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu, after consultation with the Director of Town and Country Planning, hereby approves the draft Master Plan 2045 for the Tiruchirappalli local planning area submitted by the Tiruchirappalli local planning authority.

6. The copies of the said Master Plan 2045 for the Tiruchirappalli local planning area as approved by the Government are communicated to the Director of Town and Country Planning, subject to condition that the master plan shall be reviewed every five years as per clause (b) of sub-section (2) of section 32 of the said Act.

7. The following Notification shall be published in the Tamil Nadu Government Gazette. Tiruchirappalli local planning authority is directed to ensure that the Notification is republished in the manner as prescribed in rules 12 and 15 of the Master Plan (Preparation, Publication and Sanction) Rules.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 30 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby publishes the approval of the Government under section 28 of the said Act for the Master Plan 2045 for the Tiruchirappalli local planning area submitted by the Tiruchirappalli local planning authority.

2. The approved Master Plan 2045 for the Tiruchirappalli local planning area with all its enclosures shall be kept open for the inspection of the public during working days in the office of the Tiruchirappalli Municipal Corporation during office hours.
